Welcome to the Compliance Services project's first newsletter!

The energy label and ecodesign regulations are designed to deliver real energy savings by helping consumers rank products and by setting EU minimum standards to eliminate the least-performing products from the market. 75% of EU citizens agree that the EU energy label influenced the choice of their appliance (Eurobarometer 555, May 2024).

However, ongoing market advancements necessitate adjustments to relevant legislation. This ensures that ecodesign requirements and energy labels, including crucial factors such as the energy efficiency class indication, accurately align with the market conditions and changes.

The #ComplianceServices project, supported by the EU LIFE programme, is now underway, aiming to assist key industry players, including suppliers, retailers, and installers.

Tumble dryers, heating systems, hot water and air-conditioning products, photovoltaics and solar panel technologies, and smartphones are among the product categories that either have an energy label or will have a new energy label or ecodesign requirements introduced, as the respective legislation is under preparation.

New energy labels and new ecodesign requirements for tumble dryers

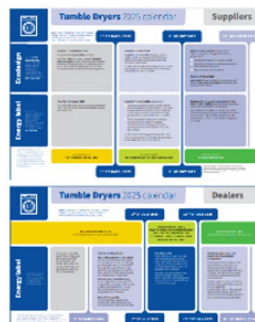
